 him that sits on the throne & the Lamb for ever & ever 2^{dly} it
 is My will and Desier that my Boday Be Decently Entered into
 its Mother Earth and all my just Debts paid 3^{dly} I will and
 Bequath My Negro Boy Ruben to My Son william owings 4ly it is
 My will and Desier that My Negro woman Ruth Should Belong to
 My son John Owings 5^{thly} it is My will and Desier that my Negro
 woman Mary Should Belong to My son Richard Owings 6^{thly} it is
 My will and Desier that William Owings Do pay out of the price
 of Ruben unto James Owings the some of two hundred Dollars John
 Owings Do pay to the 3^d James Owings out of the price of Ruth
 one hundred Dollars & Richard Owings Do pay to the 3^d James
 Owing out of the price of Mary one hundred Dollars at the Ex-
 piration of one yare after my Death 7^{thly} it is My will and
 Desier that my Son John owings Should have have My plantation
 that I now Live on with all My household furnetuer and that the
 3^d John Owings Do pay to those of My Children which is Not Naimed
 one hundred Dollars
 a Bove .. & also that My son John Should have a Black Cow & Calf
 and a Speekled hefter two yars cald & upwards all the Residue of
 My property that is Not mentioned a Bove to Be scald and Divided
 Betwen My four Daughters vis Nancy Shroock Sarah goodkin Elisabeth
 hood & Jemimah Gardner with an exception of My foristor Mare that
 mar to Belong to my Son John owings also one yare cald Colt to
 Belong to my son Richard owing and the thirty three Dollars which
 My Son William owins owes to me to Be aplied to the payment of
 My Debts & should that not Be suficient to pay my Debts as Much
 as will pay all my to Be taken out of My Crop now groeing and I

acknowledg no other Will or Wills But this to Be My Last will
and Testament signed Sealed & acknowledge in presents of us
and I Do her By apoint My true and trusted freind William
owing as My Lawfull Exstor to this My Last will and testamen
and that my son william owing attend to My Orep now a groing
and that he the 2^d William Do Be paid out of the Orep for his
trouble and services Given under My hand and Seal this 13th
of June in the yare of our Lord one thousand Eight hundred &
twenty six
