

Last Will and Testament

FIFTH: I hereby give, devise and bequeath all of the rest and residue of my estate, all
property over which I have power to dispose to Leonard Shelby Noggle.

SIXTH: I nominate and appoint Ronald Monroe Noggle
as Executor of this will. In the event that the Executor named above shall predecease me
or fails to serve as such Executor of this will, I nominate and appoint Patricia Jeanne
Mc Clelland as Executor. I further direct that no appointee hereunder
shall be required to give any bond for the faithful performance of their duties.

SEVENTH : I hereby authorize my Executor to exercise all power, rights, discretion and duties deemed necessary for the proper administration and disposition of my estate.
