I, Christopher Decker, do hereby give grant sell unto the said Christopher Decker to pay the sum of twenty dollars each to him and his heirs forever all the lands lying in Franklin County Georgia of the land lying in Franklin County Georgia, belonging to the said Decker and also all his personal property in the State of Georgia and also all woods & ways and waters courses and every the appurtenances thereof unto belonging or in any way appertaining and the revenues and royalties remainder and remainder's rents and profits of the affixed land and premises and every part thereof and all the estate rights titles interest claim property and demands whatsoever, to the said Jacob Setzer Anna Setzer Esther Setzer and Catharine Stail of us and to the land & premises hereby being so granted to them and to hold the affixed land and premises with appurtenances unto the said Christopher Decker to him and his heirs forever against the claims of Jacob Setzer Anna Setzer Esther Setzer and Catharine Stail and their heirs forever of and every other person by these presents, In witness whereof the said Jacob Setzer Anna Setzer Esther Setzer and Catharine Stail have hereunto affixed their seal the day and date above written.
